

**ORDINANCE OF THE CITY OF PATTERSON, GEORGIA  
TO CLOSE A PORTION OF ORANGE STREET AND FOR  
OTHER PURPOSES.**

THERE being presented to the City of Patterson, Georgia, to reject the offer of dedication, and abandon and close a portion of Orange Street, which appears as part of Echoland Subdivision, the City of Patterson, Pierce County, Georgia;

IT FURTHER appearing that the owners of the abutting land have signed said petition and requested that said street be abandoned, closed, and the offer of dedication rejected;

IT APPEARING that there be no adverse impact upon the citizens of the City of Patterson, in that they have access;

WHEREAS, it further appearing that the City of Patterson paid nothing for said right of way and that it is not necessary repurchase the same.

BE IT ORDAINED by the City of Patterson, Georgia as follows:

SECTION 1. That the City of Patterson, Georgia hereby rejects the offer of dedication and abandons and closes the following described section of Orange Street; Commence at a point where the northerly right of way of Plum Street intersects the right of way of Orange Street; thence north 38 degrees 45 minutes west a distance of 450 feet (said right of way is 50 feet wide) as shown on a subdivision plat of Echoland Subdivision Addition.

SECTION 2. This ordinance shall be effective when finally passed by the City of Patterson, Georgia.

SECTION 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
